# Why study professional accounting at the University of South Wales?

## Tuition in a key South Wales location

Our tuition fees are cost effective and the cost of living in the south-east Wales area is less than other locations in the UK.

### Study and employer resources

Study texts and other resources including progress tests and mock examinations\* are supplied to our students as part of the tuition fee. ### Amendments to professional accountancy delivery in 2021 due to COVID-19

Our current delivery comprises a mixture of on-campus and online sessions given the continuing COVID-19 restrictions. We will communicate with you regularly, keeping the balance of this delivery under continual review and responding to any changes to Government restrictions or guidance as appropriate. Our online delivery has been running successfully since March 2020. Our outstanding team of professional accountancy tutors have supported our students through multiple internal and external exam diets since the start of the pandemic, allowing students to progress their studies. These are just a few things that current students have said about our online delivery:

For each module, our online delivery utilises a mixture of bespoke pre-recorded lectures & tutorials (supported by multiple resources created by tutors), weekly timetabled live virtual classrooms, discussion boards and 121 pastoral and subject technical support delivered via email, telephone or video call. Students are provided with a clear study plan at the start of their studies - and the learning to be undertaken each week, along with the associated study resources, are clearly signposted on our virtual learning environment (Blackboard). Students are also provided with a study text and question practice kit at the start of their studies. Marked progress tests and mock examinations are provided for students studying towards external exams. The live online classroom sessions are a vital interactive method for us to check that students are on the right track and progressing with learning. They allow students to feel part of a learning community, engaging in group discussions and asking questions of tutors. They will always be scheduled on set days and times, following our published brochure timings. The live virtual classrooms are also recorded for students to watch later if they are unable to attend at the allotted times. Overall, our online delivery gives students flexibility in accessing resources at a time that's right for them, in line with their needs, learning styles and preferences.

# Note 1 - Diploma of Higher Education (Professional Accounting)

Students studying the Applied Skills Level can choose between sitting external ACCA exams or internal university assignments and exams. Those who obtain sufficient internal credits are awarded a university Diploma of Higher Education (Professional Accounting) as part of their ACCA studies. The internal scheme awards ACCA exemptions.

## Note 2 - MSc Professional Accounting (with ACCA tuition)

Students can choose to study our MSc Professional Accounting alongside the ACCA Strategic Professional Level modules. This is an innovative route that allows students to obtain both an MSc and their Strategic Professional exams at the same time. The syllabus of the MSc is mapped to the ACCA modules. MSc and ACCA students sit in the same classes. Internal MSc assignments and exams are sat prior to the sitting of each external ACCA Strategic Professional exam. MSc students undertake additional tutorials to build Masters skills that are highly valued by employers such as critical thinking and advanced research, analysis and evaluation skills. In addition to the Strategic Professional modules listed above, **MSc students also undertake a Business Research Project between June and September to complete their Masters programme.** 

The University of South Wales is an ACCA Platinum Approved Learning Partner, the highest level of accreditation. This means that our ACCA pass rates are consistently above global averages.

# ACCA Progression Notes

Exams must be taken in the ACCA Level order (see below), however modules within each Level can be taken in any order.

### Applied Skills Level (LW, PM, TX, FR, AA, FM) Strategic Professional Level (SBL, SBR and two from AFM, APM, ATX and AAA)

Outstanding exams in a current Level must be entered if a student wants to enter exams in the next Level. Students should complete the online Ethics and Professional Skills module before they start the Strategic Professional Level.

Students should consult the ACCA exam timetable before embarking on study of individual modules. In particular, Advanced Audit and Assurance should be studied after Strategic Business Reporting and the following module combination should be avoided: Strategic Business Leader with Tax / Advanced Tax.

Progress tests are included for all modules; mock examinations are included for externally examined modules. Our tuition fees also include the cost of a study text and question practice kit, but exclude any fees payable directly to ACCA.

# **Style of Tuition Delivery**

When COVID restrictions are lifted, we anticipate returning to a blended tuition model for the ACCA course (subject to final University approval). Our blended delivery model will include a mix of classroom-based tuition (majority of sessions) plus interactive online elements, with students only required to attend face to face classes in periodic weeks. Our online tuition will include bespoke pre-recorded lectures & tutorials, weekly timetabled live virtual classrooms, discussion boards and 121 pastoral and subject tutor technical support delivered via email, telephone or video call where required, in addition to face to face meetings. All face to face classes will also be broadcast live and recorded. Our blended delivery model will give students flexibility in accessing resources at a time that's right for them, in line with their needs, learning styles and preferences.
